ORDER

WHEREAS, recognition was granted to the institution, namely, **Astha Shikshak Prashikshan Mahavidyalaya, Plot No-1007, Village-Itawa, Post Office-Itawa, Tehsil/Taluka-Pipalda, Town/City-Itawa, District-Kota, State-Rajasthan, Pin Code-325004** vide Order No. F. NRC/NCTE/Recognition/NRCAPP-12036/166949-55 dated 18.02.2017 for conducting B.A.B.Ed./B.Sc.B.Ed. Integrated course with an annual intake of 100 students (1 unit).

AND WHEREAS, the institution submitted an application dated 05.05.2017 to the NRC-NCTE requesting for change of name of the institution from **Astha Shikshak Prashikshan Mahavidyalaya to Astha Mahavidyalaya.**

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 271st considered the case of the institution under provisions of the NCTE Act, Regulations and Guidelines issued by NCTE-Hqrs. and decided as under: -

- **The request of the institution has been considered in the light of NCTE (HQ) letter No. F.No.49-3/2016/NCTE/N&S/47143 dated 08.12.2016 which *inter-alia* provides that "With respect to change of name of the institution, this may be permitted if the land is not transferred to the existing institution proposed to be changed. If the land is already transferred from Society to the institution or if the land is the name of the institution any change in the name of institution shall essentially require change in the ownership of the land. In this case processing fees may be charged for inspection process."**

In the instant this, since the land is in the name of the sponsoring Society, the NRC decided that the institution may be permitted to change its name.

NOW THEREFORE, the Northern, Regional Committee hereby grants permission to the institution for change of its name from **Astha Shikshak Prashikshan Mahavidyalaya to Astha Mahavidyalaya** for conducting B.A.B.Ed./B.Sc.B.Ed. Integrated course with an annual intake of 100 students (2 units) instead of 100 students (1 unit).

ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Astha Shaudh Evam Vikas Sanstha, Plot No.-1007, Street/Road-Itawa, Village/Town/City-Itawa, Post office-Itawa, Tehsil/Taluka-Pipalda, Town/City-Itawa, District-Kota, State-Rajasthan, had submitted an application to the Northern Regional Committee of NCTE seeking recognition/permission to the institution, Astha Shikshak Prashikshan Mahavidyalaya, Plot No-1007, Street Number-00, Village-Itawa, Post Office-Itawa, Tehsil/Taluka-Pipalda, Town/City-Itawa, District-Kota, State-Rajasthan, Pin Code-325004 for B.A.B.Ed./B.Sc.B.Ed. Course on 30.05.2015.

**Norms and Standards for 4-year integrated programme leading to B.Sc.B.Ed / BA.B.Ed Degree
- Regarding Staff**

5.1 Faculty

For an intake of one basic unit of 50 students, faculty shall be recruited for the following Curricular Areas, with the specified essential and desirable qualifications and specializations. The number of full time faculty shall increase proportionately as per the norms indicated above. Additional faculty shall be appointed by the college/Institute subject to provisions that the faculty requirements for the curricular areas mentioned below are fulfilled.

For an intake of two basic units of 50 students each, there shall be 16 full-time faculty members. The distribution of faculty across different curricular areas shall be as under:

- Note: i) The faculty positions listed under different subject categories may teach course(s) in the Teacher Education Programme across curricular areas specified, and can cater to both foundation and pedagogy course(s).
ii) Faculty can be utilized for teaching a B.Sc.B.Ed./B.A.B.Ed programme in flexible manner so as to optimize academic expertise available.

5.2 Qualifications

The faculty shall possess the following qualifications:

A. Principal/HOD

- (i) Postgraduate degree in Arts/Sciences/Social Sciences/ Humanities / Commerce with minimum 55% marks; and
- (ii) M.Ed. with minimum 55% marks; and
- (iii) Ph.D. in Education or in any pedagogic subject offered in the institution; and
- (iv) Eight years of teaching experience in a secondary Teacher Education Institution.

Desirable: Diploma/Degree in Educational Administration/Leadership.

B. Perspectives in Education or Foundation Courses

- (i) Postgraduate degree in Social Sciences with minimum 55% marks; and
 - (ii) M.Ed. degree from a recognised university with minimum 55% marks.
- OR
- (iv) Postgraduate (MA) degree in Education with minimum 55% marks; and B.Ed. degree with minimum 55% marks.

C. Curriculum and Pedagogic Courses

- (i) Postgraduate degree in Sciences/ Mathematics/ Social Sciences/ Languages with minimum 55% marks, and
- (ii) M.Ed. degree with minimum 55% marks.

Desirable: PhD in Education with pedagogic specialisation.

[Note: In case of B and C put together, for two faculty positions, a postgraduate degree in Sociology/Psychology/Philosophy with 55% marks and B.Ed./B.El.Ed with 55 % marks and three years of teaching experience in a secondary school shall be considered.]

D. Specialised Courses

Physical Education

(iii) Master of Physical Education (M.P.Ed.) with minimum 55% marks.

Visual Arts

(iii) Postgraduate degree in Fine Arts (MFA) with minimum 55% marks.

Performing Arts

(iii) Postgraduate degree in Music/Dance/ Theatre Arts with minimum 55% marks.

5.3 Administrative and Professional Staff

q) Librarian (B.Lib with 55% marks)	One
r) Computer Lab Asstt. (BCA with 55% marks)	One
s) Office Manager	One
t) Office Assistant cum Data Entry Operator	One
u) Curriculum Lab Co-ordinator	One
v) Accounts Assistant	One
w) Helpers/ Lab Attendant	Two

The qualifications shall be as prescribed by the State Government / Affiliating body for equivalent posts.

Note: In a composite institution, the Principal and academic, administrative and technical staff can be shared. There shall be one Principal, and others may be termed as HODs.

5.4 Terms and Conditions of Service of Staff

The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per the policy of the State Government/Affiliating body.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution:-

- (i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- (ii) The affiliating body shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution as not a composite institution, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, in the existing institutions permitted for additional intake, shall have to ensure that they are to become composite gradually preferably the academic session 2017-18.

(iii) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake at any stage, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.


8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

9. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

10. The institution shall fill the GIS application within one month of issue of this Order.

11. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.



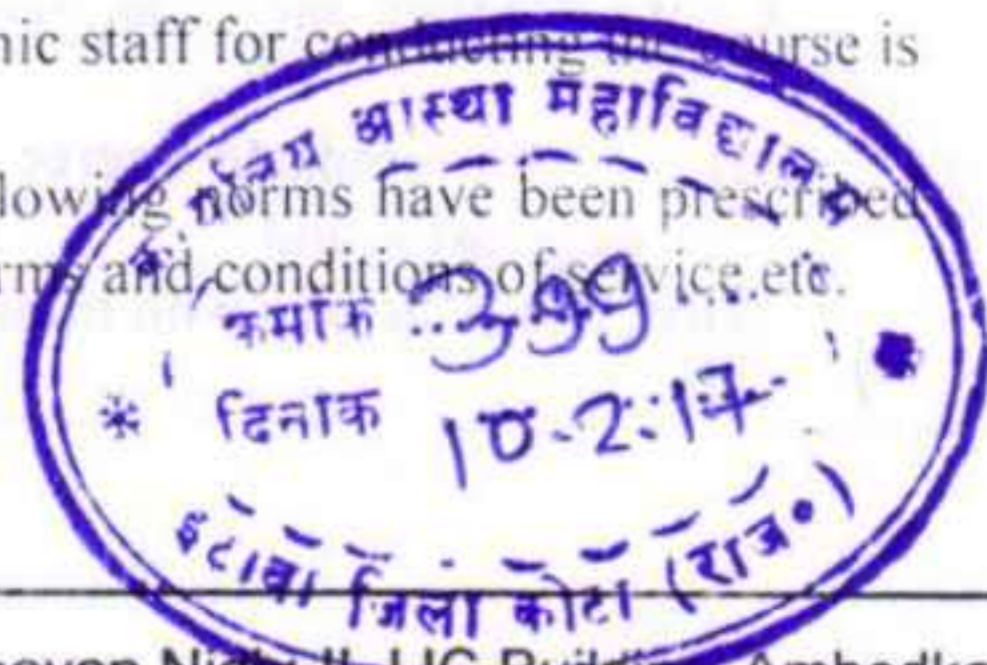
